

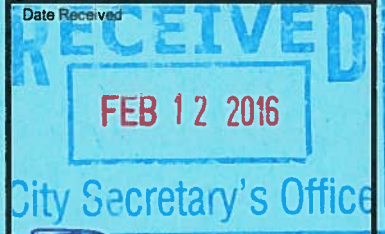
# CODE OF FAIR CAMPAIGN PRACTICES
