

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON MAY 7, 2016, FOR THE PURPOSE OF ELECTING THREE COUNCILMEMBERS FOR IRVING CITY COUNCIL, PLACES 1, 2, AND 7 FOR A TERM OF THREE (3) YEARS.

WHEREAS, the City of Irving, Texas, held a General Municipal Election on May 7, 2016, for the purpose of electing Councilmembers to Places 1, 2, and 7 for a term of three (3) years; and

WHEREAS, public notice of such Municipal Election was duly given, and such election was duly and properly held and administered in accordance with the laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965; and

WHEREAS, a canvass of the General Election returns was conducted on May 17, 2016; and

WHEREAS, it was found that the persons herein named received the following votes for said term of office on the Irving City Council of the City of Irving, Texas:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF IRVING, TEXAS:

SECTION 1. That the General election held on May 7, 2016, was duly and legally called and notice thereof given in accordance with the laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965 and the ordinance calling said election; that said election was held in strict conformity with the Constitution and laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965, and the returns thereof have been properly made to the officials of the City of Irving entitled to receive the same, and that said election properly represents the desires of the voters of the City of Irving.

SECTION 2. That the following named candidates were duly elected at said municipal election to the respective named offices of the City of Irving:

John Danish – Councilmember Place 1, District 1 – Single Member

Allan E. Meagher – Councilmember Place 2 – At Large District

Kyle Taylor – Councilmember Place 7, District 7 – Single Member

SECTION 3. It is hereby declared that the City of Irving approves and accepts the results of the General Election for Councilmembers, Place 1, Place 2, and Place 7, as set forth in the Election Returns Sheet attached hereto as “Exhibit A”.

SECTION 4. Should any court of competent jurisdiction declare any section, subsection, clause, or phrase of this ordinance unconstitutional or invalid, it is expressly provided that any and all remaining portions of this ordinance shall remain in full force and effect. The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause and phrase, without the inclusion of any unconstitutional or invalid provisions.

SECTION 5. It is officially found, determined, and declared that the meeting at which this ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting was given.

SECTION 6. This ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.
