Requiem mass will be celebrated at 4 p.m. today for Sterling James Layton, 30, at St. Mark's Episcopal Church, Sixth and Iowa. Rev. Frank B. Jarrett of St. George Episcopal Church of Dallas will officiate. Interment will be in Oak Grove Memorial Park.

The body of the Irving man was found Saturday near Los Angeles, Calif. Mr. Layton had been missing since Feb. 13 when the private plane in which he was a passenger crashed near Frazier Park, between Los Angeles and Taft, Calif.

A deer hunter discovered the wreckage Saturday in mountainous country. It also contained the bodies of Robert G. Tucker of Burbank, Calif., and George Smith of Wichita Falls.

Mr. Layton was a junior

field service engineer for Collins Radio Corp. in Dallas. He was in California to install a radar station in the area near Taft.

It was reported that the plane apparently hit a hill, then slid down 700 feet, stopping against trees. Only part of the tail section was unburned.

Survivors of the Irving man include his wife, Elaine Layton; four children, Martha Layton, Jimmy Layton, Mark Layton and Matthew Layton, all of Irving; his mother, Mrs. Martha Louise Layton of Dallas; four sisters, Mrs. Donald Mustain of Austin; Mrs. Tom Collins, Fort Worth; Mrs. John Fowle, Phoenix, Ariz.; and Mrs. Karl Waldron of Boston, Mass.

Gunshot Victim's Funeral Is Held

Funeral services were held Tuesday at the First Baptist Church in Grapevine with burial in Grapevine Cemetery for James Allen Livingston, Jr., of Irving.

His survivors include his wife; two children Jamey, 1 and Cindy, 2 1/2; his parents; a brother, Raymond of Grapevine, and a sister Mrs. Reed.

Fifty-three-year-old Tarrant County farmer James Allen Livingston admitted that he fatally shot his 25-year old son.

"God knows it was an accident," the father sobbed as he related the details of the shooting.

The elder Livingston said he left his home, three miles northwest of Grapevine, shortly after sundown Sunday to visit his son-in-law Roy Reed. Their houses are separated by a large field.

Livingston said he was in the habit of carrying his 12 gauge shotgun to "shoot skunks, because we have so many of them up there".

The farmer said he entered Reed's fenced back yard from the south, and was walking toward the house when he tripped over a toy in the yard.

"The gun went off as I tripped," said Livingston.

He was overcome with

emotion as he recalled the night's events. The father said that as the shotgun went off, "I heard someone holler 'Oh, no'."

"That's when I looked up, and I saw someone fall. I rushed over, and saw it was my son."

Livingston said that he sat beside his son, put his head in his lap and tried to comfort him. "I then went in the house and told my daughter that she'd better get some help" he said.

The father said that he was not aware that his son was even in the yard when he went to the Reed place.

"When I left, my son was at my house with his family," Livingston said.

Officers reported that the son apparently entered the Reed back yard from the north side about the time the father entered the property from the opposite direction.

Reed, the son-in-law, told a reporter he was bathing his four small children when he heard a shot at about 8:30 p.m. Sunday.

Reed said that he and his wife had not seen that either the elder or younger Livingston was near the house.

The victim of the shooting worked as a machinist.
