Rites Held for Bert Ashby, Killed in Fall

Funeral services were held Tuesday afternoon for Bert G. Ashby, 830 Wyche Drive in Irving, owner of Texas Bail Bond Co., who was killed Sunday afternoon when he was crushed by a horse at a ranch near Irving.

Mr. Ashby, formerly a Dallas criminal attorney, had just mounted a horse and was riding from a stable at The West Begins Ranch at Story and Findley Rd. when the horse reared and tossed him against a railroad tie which was being used as a fence post and fell against him. With him and on another horse was his brother-in-law, Robert L. Williams of Commerce.

He was dead on arrival at an Irving clinic. His chest had been crushed.

Born at Sherman, he was 59 at the time of his death. He played both football and basketball while attending the University of Texas from 1920 through 1922. He got his law degree from Oklahoma University in 1925 and was licensed by the Oklahoma Bar Association. He later moved to Orlando, Fla., was licensed there and was admit-

ted to the Texas Bar after moving to Dallas in 1927.

He was associated with the law firm of Clark & Clark from 1928 to 1931, and in 1937-38 he was assistant district attorney for Dallas

County.

Active as a cattleman, he raised Brahman cattle, Palomino and Quarter horses.

Survivors include his widow; a stepson, Dick Hitt of Dallas, and one grandson.
