# Murder Charge Brings Tears

—GRAND RAPIDS, Mich (UPI) —Oyo Peebles broke into tears briefly Monday at his arraignment on a charge of murder for shooting his wife after finding her in the embrace of a prominent Indiana industrialist early Saturday.

Peebles' attorney, Harold Sawyer, demanded preliminary examination on the charge and Municipal Judge Louis E. Simhauser tentatively set the examination for Thursday afternoon.

After his brief court appearance, Peebles, 41, a Rockford, Mich., industrialist and gun collector, was returned to the Kent County Jail.

The Indiana industrialist, Roy Staples, 44, who was wounded twice by Peebles, meanwhile was reported in satisfactory condition at St. Mary's Hospital here though he was still paralyzed from the waist down as the result of a bullet wound in the back.

Peebles came home early Saturday and found his wife missing. He drove to the home of one of her friends, Mary Voss, 46, peered through a

window and saw his wife sitting in Staples' lap "making love."

Peebles burst into the Voss home on nearby Silver Lake, shot his wife, Louise, 40, once in the head, then shot Staples with a .44 caliber magnum pistol.

Peebles told police he had intended only to frighten his wife and Staples, not to kill them, but that he began shooting when Staples jumped up as he burst into the Voss home.

**Irving Man Killed  
In Freeway Crash**

Earnest S. Pipkin, 49, of 914 Tanglewood was killed and Irving City Attorney James R. Rainey injured when the 1960 Oldsmobile which Rainey was driving was in a front-rear collision with a state highway department maintainer (street scraper) Tuesday morning about 10:40 a.m. in the 2400 block of Stemmons Expressway at the Motor St. overpass.

Rainey was taken to Parkland Hospital for emergency treatment and later transferred to Gaston Ave. Hospital. He received a fractured left arm and cuts about the face and head. His condition was not thought to be serious.

Pipkin, a passenger in the front seat, died instantly of head injuries when he was thrown into the windshield, according to reports from Dallas police.

Driver of the maintainer was Elvin D. Vines, 54, of 11409 Denton Rd., Dallas. Whether or not he was injured was not learned by the Daily News Texan.

Rainey recently had moved from Irving to 5227 Gaston Ave., Dallas.

Pipkin is survived by his

wife, Grace; a father, H. E. Pipkin of Dallas; two daughters, Karal Louise and Sharon Sue; a son, Larry; and one brother, C. E. Pipkin; all of Irving. Services will be at 2 p.m. Thursday at First Bap-
