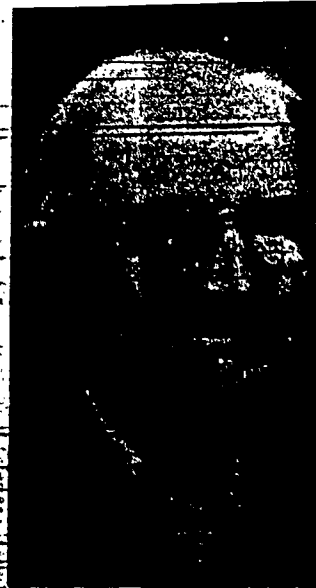

# Death Claims Actor Coburn

NEW YORK (UPI) -- Veteran character actor Charles Coburn, 84, died Wednesday at Lenox Hill Hospital, bringing to an end one of the longest active careers in show business.

The actor, one of Hollywood's most loved and most renowned oldtimers, succumbed at 3:50 p.m. EDT after undergoing throat surgery Wednesday morning.

The actor was married only a year ago last June to a 41-year-old widow.

The sprightly, octogenarian Coburn - whose professional acting covered 68 of his years - had expressed his hope only recently of living "another 10 years before departing this world." He kept busy almost to the last, enjoying in his jovial, hearty manner everything and everybody within range of his personality.

Coburn, who wore a monocle nearly half a century because -- as few people knew -- of an astigmatism in his right eye, revisited his hometown at Savannah, Ga., early this year. As outspoken as

ever he proposed in an interview that the stirring strains of "Dixie" ought to replace that "frightful piece of music" called the Star Spangled Banner.

He described his own attitude: "I would stand on my head in the middle of the street - if it would sell tickets."

# Housekeeper Hugs Charges to Death

MILWAUKEE, Wis. (UPI) -- A buxom housekeeper confessed Friday she "squeezed" two small brothers to death against her bosom when they angered her by tossing toys and toothpaste around their home. Lucille Adams, 24, told investigators she got

an "urge to squeeze" the boys from recent news reports of a Dubuque, Iowa, babysitter who hugged three children to death.

"I just went haywire," Miss Adams told District Attorney William McCauley.

William Craig Jr., 27, found the bodies of his sons Donald, 4, and Ronald, 2, in their beds when he returned home from his overnight job Friday morning.

Craig awoke the housekeeper. She refused to talk to him. He telephoned a sister in law, Mrs. James Craig, and shouted hoarsely:

"This is Bud. My kids are dead. The housekeeper has killed my kids."

By a grim coincidence, the boys' mother—Craig's second wife from whom he had been separated—arrived Friday from Kansas City, Mo., to visit them. She is seven months pregnant.

McCauley said Miss Adams told him she became angry at the boys Thursday because they threw shoes and toys around their five-room apartment and spattered the rooms with toothpaste.

# Crosley Dies

## In Cincinnati

CINCINNATI, Ohio (UPI) -- Powell Crosley Jr., sportsman and businessman whose fabulous career succeeded in almost everything except the introduction of compact cars in this country, died Tuesday.

Crosley, who introduced night baseball, was president and owner of the Cincinnati baseball team. He saw his beloved Reds win the World Series four years after he took over. He was responsible for major league baseball remaining in Cincinnati.

Crosley pioneered in the manufacture of radios, entering the field because he felt radio sets should be within the reach of everybody. He used his profits to establish WLW radio station, the home station of what is now one of the country's major radio and telecasting organizations.

The organization has television stations in Cincinnati, Dayton, and Columbus, Ohio; Atlanta, and Indianapolis. He also owned WSAI here but sold it to Marshall Field of Chicago.

But Crosley's love was the automobile, a field in which he was far ahead of his time. He built a car when he was 12. In the 1930's, after making millions in the manufacture of radios, refrigerators and other appliances and in broadcasting, he tried to make a small car.

But he would not allow anybody to call his cars, which bore his name, miniature. He would drape his lanky frame under the wheel, drive jauntily away to show the Crosley was "big enough for anybody."

But America, a generation ago, was not ready for the compact car. Finally in 1952, he gave up, devoting his time since to the ball club and his hobbies-yachting off Florida, fishing in Canada, and raising cattle on his island off the Carolina.

Gerry Mae Feury, a pretty waitress, said Friday that a man who led her on with talk of an Easter wedding when he already had a pregnant wife, invited her early Friday to shoot him. She said she accepted the invitation.

The man, W.A. Cunningham, 34, died in the driveway of his home, saying, according to Miss Feury: "I still love you but you killed me." Mrs. Cunningham, who had just dismissed Miss Feury as a "cheap. . . ." heard the shots but didn't see the shooting.

Police charged Miss Feury, 24, with murdering Cunningham and put her in jail at Fort Worth. She said that in addition to Cunningham's empty promises and invitation to shoot, he had provoked her further.

He had accused her of being pregnant, she said, and by a man other than him.

Miss Feury works in a bar, which was where she met Cunningham, foreman of the paint shop at a General Motors assembly plant. She said he told her he was divorced and would marry her Easter Sunday.

The wedding was set back to this Saturday and then he told her he had to go to Detroit. Miss Feury, in a statement for the district attorney, said she had already invited friends to the wedding.

Miss Feury's statement for the district attorney contained "deepest apologies" to the widow, who is expecting her third child in four months.

## 2 Drown At Cypress
