NOT IN CUBA

Paret's Body To Be Buried In the States

NEW YORK (UPI) — Boxer Benny (Kid) Paret, who lost his nine-day battle for life early Tuesday, will be buried in the United States, rather than in the Castro-Cuba he opposed.

Those were the funeral plans desired by the young, pregnant widow of the 24-year-old Cuban fighter who breathed his last at 1:55 a.m. east Tuesday without ever regaining consciousness. Paret, who had been in a coma since he was knocked out by Emile Griffith in their world welterweight championship bout at Madison Square Garden, March 24.

Mrs. Maxima Crespo of Cuba, Paret's mother, wanted her son buried in the land that gave him birth, according to the fighter's manager, Manuel Alfaro.

But Mrs. Paret wants her husband buried in Miami.

she would not allow her husband to be buried in Cuba because "my husband worked in the underground. I don't want his body used for propaganda."

The attendant said Mrs. Crespo told her daughter-in-law that Castro had planned to give the boxer a huge state funeral in the event he died and his body was brought to Havana for burial.

The attendant said Mrs. Paret said, "His body will never go back to Cuba as long as Cuba is ruled by that man."

That Mrs. Paret had prevailed was indicated by a spokesman for the funeral home where Paret's body was brought Tuesday night.

"Our instructions are to ship his body to Miami on Friday," said the spokesman. "We assume that burial will be in Miami."

Paret, the only world champion in boxing history to die as a result of injuries suffered in a bout, died without regaining consciousness, according to Manuel Alfaro, who was manager of the fighter's last fight.

Train Rams Oil Truck Kills Three, Hurts One

CHANDLER, Tex. (UPI) -- A Cotton Belt freight smashed into a truck loaded with 6,000 gallons of crude oil Friday. The collision caused a series of explosions and a 100-foot holocaust that killed three train crewmen.

The driver of the tank truck escaped with facial burns and scalp abrasions. The explosions and fire for a time threatened to spread to downtown Chandler.

One of the seven units of the diesel locomotive exploded as well as the truck. Part of the locomotive landed on the roof of a home owned by Mrs. B. M. Whitehead. She was unhurt, and her home was not badly damaged.

The train ran a mile past the collision point, spreading fire along the roadbed, before it stopped.

Towering smoke was visible in Tyler, 10 miles northeast of this tiny East Texas community of 715 persons. The fire towered 100 feet in the air.

The explosions destroyed the truck and its cargo and one unit of the seven-unit locomotive. The diesel unit that exploded cost \$300,000 to \$400,000 when new. There was, however, no overall estimate of the damage.

The victims were engineer J. T. Piles, 53, head brakeman, K. P. Jones, 67, and fireman H. E. Malone, 52, all of Tyler.

Piles and Jones were trapped in the cab of the locomotive. Malone was apparently blown from the train by the explosion. His body was found

clothes.

McKinney said the explosions smashed windows in his home. He said debris was scattered all along the roadbed. An automatic braking system eventually stopped the train.

The truck had almost cleared the track when the train hit it. It had just been loaded with crude oil from a Humble Oil Co. well in South Chandler

field and was believed en route to Longview. The State High-

way Patrol said the truck was owned by Permian Corp. of Houston.

Piles and Jones were trapped in the cab of the locomotive. Malone was apparently blown from the train by the explosion. His body was found by the tracks. He died en route to a Tyler hospital. James Luce, 33, of Swan, Tex., driver of the truck, was reported in good condition at Tyler Medical Center.

Bill McKinney, who lives near the scene of the accident, said Luce leaped from his truck and rolled in dirt to put out the flames on his

Profaci, Alleged Mafia Leader, Dies

BAYSHORE, N.Y. (UPI) -- Reputed Mafia leader Joseph Profaci, 65, called by Atty. Gen. Robert F. Kennedy "the most powerful" figure in the U.S. underworld, died Wednesday night of cancer.

Profaci's death in Southside Hospital in this Long Island community was announced Thursday. He was admitted to the hospital Tuesday.

Police said that the wealthy Profaci maintained a respectable facade as proprietor of the Mamma Mia Importing Co., which dealt in olive oil from Italy. But the business was only a front for Profaci's underworld activities, according to police.

Profaci had extensive business and underworld interests in Brooklyn and was the reputed Mafia leader in the New York area. Despite his activity, Profaci went to jail only once, when he was 20. He had been imprisoned in Italy for a year.

The Italian immigrant came to the United States in 1921. He was arrested on a gun charge in 1928 at an underworld convention in Cleveland, Ohio, which police described as a Mafia council meeting.

Nothing came of the arrest and Profaci was able to keep out of the limelight -- but not police investigators' files -- until November, 1957. At that time he and 64 other underworld figures were seized at the infamous Apalachin, N.Y., gangland convention.

Profaci eventually was convicted of conspiracy to obstruct justice, but the verdict

was reversed by a higher court. The reversal saved him from denaturalization and deportation.

A federal judge in 1958 ruled Profaci should lose his citizenship because he lied about his criminal record in Italy, but again he was saved by a higher court reversal.

Profaci lived in Brooklyn with his wife, Unifa.
