

Three Killed As Truck, Bus Collide

NEW BRAUNFELS, Tex. (UPI)—A huge truck roared out of control across a divided highway Tuesday and crashed into the side of a Greyhound bus, killing three persons and injuring 10 others.

The victims were identified as Mrs. Johnnie K. Gafford, 58, a beauty operator from San Antonio; Daniel Arthur Morse, 69, of Hollis Queens N. Y., and Ben Rodriguez, 69, of Dallas.

All of the injured were bus passengers except the driver, Lawrence R. Clayton, 46, of Dallas. Five of the injured were discharged from hospitals. None of the other five was in critical condition.

There were 13 passengers on the bus. Most of them were asleep.

The accident happened at 5:20 a.m. on U.S. Highway 81, seven miles south of New Braunfels and 20 miles north of San Antonio.

CINCINNATI, Ohio (UPI) - Former National League umpire Larry Goetz died Wednesday en route to Cincinnati General Hospital a few minutes after becoming ill at home.

Idle during the 1957 season because of illness, he was dismissed from the umpire staff by National League President Warren Giles. He soon was hired as a baseball commentator by the Mutual Broadcasting Co.

The loud and fast talking Goetz had a somewhat stormy career as an umpire, often feuding with players and officials. He also had a long battle with the league office, claiming umpires should be included in the ball players' pension plan.

Teenagers Admit Slaying Friend

SAN ANTONIO (UPI.) -- Two teenage brothers admitted under questioning Monday that they shot a 14-year-old swimming companion to death Saturday and blamed the murder on a youth gang. The shooting of Henry Gomez at a creek just outside the city Saturday prompted Bexar County Sheriff Owen Kilday to ask for aid from the Department of Justice in controlling a wave of teen-aged gang shootings.

Kilday asked U.S. Atty. Gen. Robert Kennedy Sunday for help in the wave of gang-type killings that has resulted in 100 murders in the past two years.

Chief sheriff's office investigator Tony Morine said Monday he had not been satisfied with the boys' story that a carload of young toughs shot the Gomez boy to death.

The younger brother, 14, broke down Monday and admitted that they accidentally shot the other boy with a pistol. The bullet went through

his eye, he said, and then they shot him through the chest to put him out of his misery.

His 16-year-old brother corroborated the story, Morine said. Both boys were given lie detector tests and paraffin tests were run on the gun.

The boys said they concocted the gang story after the shooting. They said they had taken the gun to the place they had been swimming so they could shoot at cans in the water.

Kilday, in a hospital for treatment of a kidney disease, Friday ordered deputies to search cars driven by juveniles for weapons.
