Suspect Investigated In Langdon Murder

BROWNSVILLE (UPI)-- Authorities worked Thursday to establish the whereabouts of David Putnam, 25, on March 21, the day Fort Worth coed Jane Langdon was raped and shot to death in Phoenix, Ariz.

Officer found a torn blouse and a packet of matches bearing a Phoenix address in Putnam's motel room, following his arrest on a federal warrant in Matamoros, Mexico.

Brownsville authorities said they would try to find out whether Putnam, who went under several aliases, was in Phoenix on March 21, the day Miss Langdon disappeared. Her body was found near Phoenix the next day in an abandoned mineshaft.

Putnam was held in lieu of \$5,000 bond on an FBI charge of taking a stolen car from Dallas into Mexico. The FBI said Putnam rented the auto March 25 in Dallas.

Putnam said he had not been

in Phoenix for several years. He said he got the blouse from a prostitute girl friend. Putnam was picked up on the red light district of Matamoros.

Putnam claimed to be a third-year student at the Baylor Medical School in Dallas, but school records showed he was not enrolled.

The arrest of two suspects at Galveston Tuesday failed to produce a lead to the killer. Arizona police Lt. Lester Jones left Galveston Wednesday, apparently convinced that Ronald St. John, a 19-year-old escaped mental patient from an Arizona institution, and confessed killer of two, was not connected with the slaying of Miss Langdon, daughter of Fort Worth civil appeals Judge Jack Langdon.

Jones questioned St. John and Ralph David Casey, an employe at the mental institution who helped St. John escape.

First Movie Owner, W. B. Lawrence, Dies

Funeral services were to be held Thursday for Woodford B. Lawrence, 91, of 415 S. Jefferson. He died Tuesday in Methodist Hospital after a brief illness and poor health for about a year. Lawrence was born in Warren County, Kentucky, March 12, 1872. He married Miss Birdie Kinser, also of Kentucky, in 1890, and they moved to Irving in 1909. To this union seven children were born, and three preceded their father in death.

Lawrence was the first Irving theater owner and at the same time made it possible for the businessmen in the area to have electricity for their businesses through the use of his generator. After that, he owned and operated an unclaimed freight store. A Methodist, Mr. Lawrence at the time of his death had been retired just 10 years.

Mr. and Mrs. Lawrence celebrated their 70th wedding anniversary in 1960.

He is survived by his wife, Birdie; three daughters, Mrs. P. V. Stewart of San Antonio, Mrs. N. V. Mobley and Mrs.

J. C. Kirby, both of Grand Prairie; one son, Billy Lawrence of Irving; 19 grandchildren and 17 great-grandchildren.

Johnson Flies To Rites for Sen. Lehman

New York (UPI) -- More than 2,000 persons, led by President Johnson, crowded Temple Emanu-El Sunday to attend the funeral services for Herbert H. Lehman, former U. S. senator and a four-time governor of New York. Lehman, 85, died Thursday of a heart attack.

An additional 1,500 persons in an adjoining hall sat quietly while they heard Dr. Julius Mark, senior rabbi of the temple, eulogize Lehman as a man "whose great heart was literally on fire with a passion for human freedom."

Among the mourners, besides the President, were seven justices of the Supreme Court, Atty. Gen. Robert F. Kennedy, Gov. Nelson A. Rockefeller, U. N. Ambassador Adlai Stevenson, and Labor Secretary Willard Wirtz.

BALTIMORE, Md. (UP) -- Gene (Big Daddy) Lipscomb, 290-pound pro football star famed for his size and strength, died suddenly Friday and doctors said. The presumption is that death was caused by an overdose of narcotics.

The 6-foot, 6-inch Lipscomb, a member of the Pittsburgh Steelers team after years of stardom with the Baltimore Colts, was found seated at a table in the kitchen of a friend's apartment early Friday morning. He was unconscious and breathing heavily.

An ambulance took him to Lutheran Hospital, but he was pronounced dead on arrival.

New York 'Copter Crashes, Kills Six

NEW YORK (UPI)--A New York Airways helicopter, transporting businessmen on a routine 10-minute "executives' hop" to Wall Street, crashed and burned on takeoff at Idlewild Airport Monday, killing all six persons aboard.

Eyewitnesses said the 25-seat Twin-blade craft exploded into fragments about 100 feet above the ground.

Three of the victims were members of the crew. They were identified as Frank Loturco, chief pilot of New York Airways, Joseph Giambatista, co-pilot, and stewardess Marie Lourguett.

The names of the three passengers were not immediately made public.

The helicopter service is used frequently by visiting businessmen pressed for time to speed their movements from Idlewild, situated on the outskirts of the city, into Manhattan's Wall Street area, the nation's business center.
