Attorney Convicted Of Killing

MINNEAPOLIS, Minn. (UPI)
-- Dapper criminal attorney T. Eugene Thompson Friday night was convicted of first degree murder in the bludgeon - slaying of his pretty heiress wife and was immediately sentenced to life at hard labor in the Minnesota State Penitentiary.

The six-man, six-woman district court jury returned the verdict about 26 hours after the "murder for hire" case was placed in its hands at the conclusion of a marathon, sensation-marked trial.

Conviction of first degree murder carries a life sentence in Minnesota, where ~~capital punishment~~ was outlawed more than a half-century ago.

The jury accepted the state's contention that the dimple - cheeked, crew-cut Thompson, 38, staged and directed the bludgeon - stabbing slaying of his wife Carol, 34, so he could take up a new life with petite Mrs. Jacqueline Olesen, 27.

Thompson blinked his eyes -- almost in tears -- as the verdict was announced.

Negro Confesses Brutal Killing

MIDLAND, Tex. (UPI)- A
husky young short order cook
confessed Tuesday he dragged

the wife of oil millionaire-
sportsman Fred Turner Jr.
screaming from a balcony and
pistol-whipped her to death in
her \$300,000 home, police
said.

James Lee Marton, 22, a
Negro said he pulled Mrs. Ju-
liette Turner into a bedroom,
bludgeoned her with a .38
automatic pistol and beat her
with his fists.

Mrs. Turner's daughter,
Mrs. Clarence Scharbauer,
Jr., was knocked unconscious
in the library.

Marton was arrested hiding
in the attic of a nearby gar-
age converted into a chemical
laboratory. Owner Russ
Craddick spotted him and cal-
led police. Marton was charg-
ed with murder.

Turner, whose horse Tony
Lee won the 1959 Kentucky
Derby, returned home from a
trip to his ranch at Las Veg-
as, N. M., to learn of his
wife's death.
