Mrs. Churchill

Killed Herself

LONDON (UPI)--A coroner Thursday found that Mrs. Diana Churchill, eldest daughter of Sir Winston who had devoted herself to helping persons with suicidal tendencies, killed herself by taking an overdose of barbiturates.

The body of Mrs. Churchill, 54, who used her maiden name after her divorce from Commonwealth Relations Secretary Duncan Sandys in 1960, was found in her apartment in the Westminster district of London Sunday.

After listening to the testimony, Coroner Gavin Thurston ruled that Mrs. Churchill "died of acute barbiturate poisoning, self administered, and so took her own life."

Members of her family and her household testified that Mrs. Churchill had appeared in good spirits Saturday.

Father, Daughter Dead From Canned Whitefish

KNOXVILLE, Tenn. (UPI)---A father and daughter died Monday of apparent food poisoning resulting from eating contaminated whitefish purchased at a Kroger's supermarket in a fashionable suburban area.

Five, possibly six, other persons were undertreatment-ized all apparently purchased for the same cause. the fish at the same store.

Dr. Harold Kelso, head of Kroger's Western Plaza branch, the Knox County Health Department, said the death of furniture company executive David S. Cohen, 36, and his daughter, Amy Beth, 10, apparently was due to eating the contaminated whitefish Saturday. They were hospitalized Sunday night.

Samples of the smoked fish and other specimens were rushed to the State Health Department at Nashville for analysis.

The smoked fish was removed from the shelves of the Kroger supermarket in Knoxville. No other supermarkets in the Knoxville area carry the brand, it was reported.

Kelso said the suspected smoked fish, in a plastic wrapper was found in the Cohen home and was labeled "smoked whitefish chubs." Its packer was Dorbos Fisheries of Grandhaven, Mich.

Kelso said it was believed that botulism, a deadly bacillus that can infect preserved foods, was the cause of the Cohens' death.

Cohen was a vice-president of the Berkline Corp., a furniture manufacturing plant in nearby Morristown, Tenn. He lived in Knoxville and was active in Jewish community affairs here.

The hospitalized persons all were reported in fair condition.

Divers Find Body In Creek Waters

The waters of Delaware Creek Tuesday morning claimed the life of an 11-year-old Irving boy.

Lester Lee Coleman was pronounced dead shortly before noon at Professional Center Hospital after efforts to revive the boy failed. He was the son of Mr. and Mrs. Harold L. Coleman of 1622 Maple Ave.

The boy drowned shortly after 11 a.m. Tuesday when he jumped into approximately 12 feet of water in Delaware Creek that crosses Maple Avenue near the southern tip of Nursery Rd. The "swimming hole" is located about 100 yards west of an iron bridge that crosses Maple.

James, 13, brother of the drowned boy, told the News-Texan he and his two brothers, Lester and Donald, 10, and a neighbor, Von Wayne Quinn, 11, had gone down to the creek to go swimming. The boys said they had been warned by their parents before to "never go swimming in the creek."

"Lester got there first," James said, and took off his clothes and jumped into the water. He said the child never came to the surface.

The children ran to their nearby home and called a sister, Mary Lee, 17, who notified the boys' father.

They returned to the scene and another neighbor, Frank Childress of 1602 Maple Ave., jumped into the water in an

attempt to locate Lester. The father said the boy floated to the surface of the water one time and was caught in some vines along the bank. But nobody was able to reach the boy then. The body then disappeared.

Police Officer Jerry Lane arrived on the scene with a resuscitator and immediately called for police divers Donald Proffer and John McCabe in efforts to locate the boy.

The two divers and the neighbor, Childress, were in the water when the boy's body was brought up. It was put in a waiting Brown ambulance and Officer Herb King had the resuscitator in action while the body was transferred to Professional Center.

The two brothers of the victim said the boy could not swim and did not think the water was so deep.

Scratches on the boy's back indicated that he had possibly become entangled in briars or vines along the bank.

The family lives in a small home located behind the W. E. Johnson Produce Co. at 1622 Maple Ave. The father has worked for the Johnsons since he moved his family here last October from Alabama.

The boy is survived by his parents, four brothers, H. L., 26, John Ouis, 25, James and Donald; two sisters, Opalree, 21, and Mary Lee, 17.

The family did not know at mid-afternoon if the child would be buried in Irving or in Alabama.

Tom Connally, 86, Buried Wednesday In South Texas

MARLIN, Tex. (UPI). --- Tom Connally, the Texas giant who helped shape the nation's foreign policy during 36 years as a congressman and senator, was buried under a live oak tree Wednesday in Calvary Cemetery.

The thin and frail shell of a powerful senator was laid to rest in the red gravel soil beside the body of his first wife. The funeral services were delayed for 10 minutes for the arrival of Vice President Lyndon B. Johnson from Washington.

Other state and national dignitaries attended the simple funeral.

Connally, who retired from the Senate 10 years ago, died Monday in Washington at the age of 86. He had been in poor health and then suffered pneumonia. He had lived in Washington with this second wife.

The body was returned for burial to Marlin, a city of 10,000 in Central Texas, where Connally started his political career.

Funeral services were held in the buttressed red brick First Methodist Church, where Connally was a member and where, at the age of 33, he had been a steward and member of the committee that raised funds to construct the building.

When the last strains of the hymns by organist Mrs. Jan Linker of Waco, Tex., ended, the coffin was brought to the church vestibule and opened. The mourners filed past.

Vice President Johnson, near the end of the line coming out of the church, stopped and put on his glasses. He paused for a long moment over the opened coffin, then

took off his glasses and walked out into the sunlight.

At the cemetery, a short scriptural verse was read and a brief prayer was said.

Connally's nephews were pallbearers.

The \$1,400 coffin was encased in a \$250 vault for interment. Burial was at 3 p.m. (CST).

The funeral service lasted 15 minutes.

"Among the statesmen of this world, Tom Connally was a giant," said Rev. Asbury

Lenox, pastor of the church.

"Among his colleagues in the House of Representatives and the United States Senate, he was a revered leader and a distinguished American.

"Among his constituents and neighbors at home, he was a warm friend..."

Those gathered here have met in adoration and praise of almighty God who gave Tom Connally to us and to the world.

"The Lord giveth and the Lord taketh away; blessed be the name of the Lord."
