# GP man murder suspect

Irving police are holding a Grand Prairie man in custody for questioning in connection with the April 29 murder of Patricia Anne Garcia and her unborn baby.

A 34-year-old man was arrested at his Grand Prairie home on Gilbert Road in Shady Grove this morning on investigation of murder, said Lt. K.L. Roe.

Roe declined to elaborate on the arrest other than to say it came at 2:45 a.m.

Garcia had gone to the auxiliary U.S. Post Office at Plymouth Park Shopping Center to purchase some stamps when she was attacked and stabbed repeatedly in the throat.

A passerby discovered Garcia lying unconscious in the parking lot of the shopping center at 9 p.m. A doctor who had been shopping nearby administered aid to the woman until paramedics arrived and rushed Garcia to The Irving Hospital.

Despite efforts to save the woman, Garcia died at 10:16 p.m. As doctors realized they were going to lose the woman they attempted to save her unborn child by performing a Caesarean section. Doctors delivered the premature baby, but the infant died at 10:20 p.m.

The brutality and senselessness of Garcia's murder sent shock waves throughout the entire Metroplex and left residents outraged.

Irving police officers canvassed the area around Plymouth Park Shopping Center in search of witnesses who may have seen something. One officer said that while talking to people in the area it was obvious that there was a sense of fear in the air.

Within a matter of days, interested parties had offered rewards totaling \$15,000 in an attempt to sniff out information which would help police arrest Garcia's killer.

Yet another individual, who requested anonymity, spent Wednesday making arrangements to open a reward fund account at an Irving bank.

The Dallas businessman and former Irving resident said the account would allow individuals to pool their resources together to make one large reward.
