# When Irving resident stood up to injustice

□ Local man chases teen shoplifters;

one turned out to be armed, dangerous

In a world where apathy is the norm, Michael Levey was willing to stand up to injustice.

And it cost him his life.

On Wednesday, Levey, a 34-year-old Irving resident, was fatally shot in the back and neck after trying to stop four teen-agers who were suspected of stealing some jackets and caps from the Foot Locker store at the Forum 303 Mall in Arlington.

It was just after 5 p.m. when Levey was shopping at the mall when he saw three suspects run out of the Foot Locker with the stolen items. An employee was chasing

the suspects, and Levey soon joined in pursuit.

The three suspects ran out to the parking lot where they met a fourth suspect, who was driving a 1978 gold Oldmobile Cutlass. As the three suspects tried to get into the car, Levey was able to grab the car keys out of the ignition. The suspects, however, managed to lock themselves into the car.

At that point, Levey started beating on the car and ordering the four suspects to come out, police said. Finally, the suspects appeared to capitulate and came out of the car. As they did, however, one of the 15-year-old suspects shot Levey once in the upper part of the back and neck. He later died from

the gunshot wound.

By 9:30 p.m. Wednesday, all four suspects were in custody and, as of Friday, all four were being held in a juvenile detention center in Fort Worth.

"Obviously, this type of action (trying to thwart a holdup) is not something that we recommend people do," said Arlington police

spokesman Dee Anderson. "When you think about it, no amount of merchandise is worth losing your life over.

nire the way he jumped in there and tried to do something. It's easy to look back now and say he just should have gotten the license plate number and let it go but, in his defense, he didn't know that the suspects were armed. They never flashed a weapon of any kind while he was chasing them."

Dr. Tony Ronack, a psychiatrist at CPC Millwood Hospital in Arlington, said there are a lot of different reasons why people will take extraordinary risks to help people they may not even know.

"It may stem from a lot of things," Ronack said. "It may not be as much a hero complex as it is a simple need to prove themselves to other people and build their own self-esteem. There's also a big complaint about apathy in our society today. Everybody seems to

think that nobody cares about anything anymore and there are a lot of people out there who want to prove that theory wrong."

Ronack added that sometimes, during the heat of the moment, people do things that they wouldn't normally do.

"It's like the stories you hear about the guy lifting up a car off someone's leg after an auto accident and other stories like that," he said. "The adrenalin is pumping so fast that it sometimes give you super-human strength for a short time or it makes you do things you wouldn't normally do.

"After hearing this particular story about this man getting shot at the mall, I was thinking about how sad it was for him to get shot just because he was trying to stop some kids from stealing some clothing. But, when that adrenalin is pumping, it can make you do things that, if you stopped to think about, you probably wouldn't normally do."

# 18-year-old indicted in cabbie's death

## □ One suspect remains at large in case

A Dallas grand jury has indicted 18-year-old Carlo Martinez for the murder of an Irving taxi driver, but a fourth suspect in the killing remains at large.

Martinez and two 16-year-olds were arrested in connection with the Aug. 2 slaying of Robert Eugene Long, 29, of Executive Taxi. A tow truck driver on a repossession outing discovered Long's body slumped over the wheel of his taxi in the northeast parking lot of Estrada Apartments in Carrollton at 2:30 a.m. Long was transported to a hospital where he was pronounced dead at 1:32 a.m.

A police autopsy report determined Long was shot twice in the front of the neck and once in the back of the head.

A trial date for Martinez has not yet been set by District Judge John Cruzo. He is being held in Lew Sterrett Justice Center on \$25,000 bond.

If Martinez is found guilty of the

first-degree felony he can be sentenced to up to life imprisonment in the Texas Department of Corrections and fined a maximum of \$10,000.

The names of the two 16-year-olds who are in custody have not been released. Pre-trial hearings for the two began Wednesday morning. A hearing to determine if the youths will be tried as adults may also be heard in juvenile court. One of the 16-year-old boys is believed to be the trigger man in the murder.

Meanwhile, the fourth suspect, also 16 years old, remains at large, according to Carrollton police.

The youth, a resident of Grand Prairie, left town following the shooting, ostensibly to take a family vacation.

He has since returned to that city but thus far Grand Prairie police have been unable to catch up with the suspect, according to Carrollton police.

"They haven't been able to find him," Carrollton Sgt. Robert Digman said. "They're circulating his

picture in Grand Prairie. We're pretty certain he knows what's going on."

He said Carrollton police believe robbery was the motive for the slaying.

"We feel certain that one of the 16-year-olds is responsible for the shooting," Digman said. "And robbery was the motive."

Long was killed in the early morning hours of Aug. 2 after he picked up a fare at Irving Mall shortly after midnight, and after radioing in to his dispatcher that the fare's destination was in Carrollton.

When Long arrived at his destination, four people in the cab, Martinez and three 16-year-olds, tried to rob Long, according to police accounts, which also noted that nearby neighbors heard an argument ensuing from the location of the cab.

No money was taken from Long's taxi, but police nevertheless suspect that robbery was the motive. The engine of the taxi was still running when police arrived.

Martinez and two of the other suspects, all Grapevine residents, were picked up within two days of the murders.

Carrollton police say Larry Corpus of Grapevine is believed to be the person who pulled the trigger the night Long was murdered.

Depending on the grand jury's decision, Corpus could be facing charges of capital murder which has a maximum penalty of death by lethal injection.

Already indicted on a charge of murder is Carlo Martinez, 18, is also from Grapevine.

A second 16-year-old also was arrested in connection with the murder, but it has not been determined whether or not a certification hearing will be held for him.
