

□ Initial search for missing woman began in South Irving after arrest

A search of South Irving's Trinity River bottoms has turned up no clues to the whereabouts of a Dallas woman missing since Friday, Irving police said.

After pulling over a Blazer owned by Dallas' Teri Edwards, police used a helicopter borrowed from the Fort Worth Police Department in their fruitless search Saturday of the area near the intersection of Hunter Ferrell and South Meyers roads.

"We did a pretty thorough job searching the area, and we are satisfied there is nothing there," IPD

Sgt. Jim Alford said.

By Tuesday, the search had moved to Henderson County's Cedar Creek Reservoir, near Malakoff. Dallas police received information that Harris had been last seen near the reservoir, prompting the search there.

"Dallas police are searching other areas. They are not searching the Irving area for Ms. Edwards," said Sydney Gomez, spokeswoman for the Irving Police Department. "The information Dallas has leads them to believe she would not be in Irving."

At 8:30 p.m. Saturday, police stopped Edwards' Blazer on the eastbound State Highway 183 service road. The driver, Roy Glenn Harris, 24, of Oak Cliff, was arrested after police discovered that the Blazer was registered to Edwards.

Irving authorities charged Harris with unauthorized use of a motor vehicle, along with the minor charge of failure to display a license plate. Dallas authorities charged Harris with aggravated robbery and investigation of murder and kidnaping in connection with Edwards' disappearance, Gomez said.

Harris was held in the Irving jail for Dallas authorities until he was transferred to facilities at Lew Sterrett Justice Center on Tuesday afternoon. His bail was set at \$300,000 on Sunday.

Irving police documents revealed that when Harris was stopped, officers found bloodstains inside the Blazer, women's clothing hidden under the seat and the contents of a woman's purse spilled across the floorboard.

The incident began after a citizen flagged down a passing patrol car and told the officer

that the Blazer's driver had left a service station at Rock Island Road and MacArthur Boulevard without paying.

The officer found the Blazer speeding east on the south service road, failing to yield for other vehicles, Gomez said. Because police were able to trace the path of the Blazer from the service station north to 183 and then east toward Dallas, suspicions were aroused that clues might be found in the river bottoms.

The initial stop was for a simple traffic violation. A computer check of the license plate — which had been removed and put inside the car, police said — revealed that the vehicle belonged to Edwards.

State records show that Harris was released on parole Feb. 28 from a 10-year burglary-of-a-habitation sentence in Dallas County. He began serving that sentence on March 1, 1991.

Harris had been given a seven-year sentence from Galveston County for the June 12, 1988, burglary of a building, according to reports. Both were non-violent convictions, according to the Texas Pardons and Parole Board.

Harris had been working in Dallas at a television repair shop.

"We have asked the parole board for an emergency warrant. If we put a warrant on him, he won't be able to set bond," said Raven Cazen, media spokesman for the pardons and parole division of the state Department of Criminal Justice.

Cazen said Harris had been arrested for parole violation Feb. 25 after burglarizing a building, failing to report to his parole officer and changing addresses.

Edwards, who lives in the 3800 block of Turtle Creek Boulevard of Dallas, has been missing since Friday. She was last seen leaving work at the international services division of Baylor University Medical Center.

She had called her sister about 6 p.m. Friday, saying she planned to stop at a bookstore to pick up a present before arriving at her sister's home, family members told Dallas police.

Edwards is described as 5 feet 10 and 140 pounds, with brown hair, green eyes and a fair complexion. Individuals with information about her are asked to call the Dallas Police Department at 670-1633.
