Carrollton man dies in SH-183 collision

A 21-year-old Carrollton man was killed early Sunday morning when the vehicle he was driving collided head-on into another automobile on State Highway 183 in Irving.

Police said Victor Arevalo was taken to Parkland Memorial Hospital, where he was pronounced dead from the injuries he suffered in the accident.

Arevalo, who was driving a blue Toyota Corolla, was heading westbound in the middle lane of eastbound traffic when he collided with Irving resident Jose Garcia, who was driving a

white Isuzu pick-up truck, according to police reports.

"(Arevalo) was going the wrong way in the center lane of eastbound traffic," said David Tull, public information officer for the Irving police department. "This is a possible alcohol-related accident, ... but it is too early to determine."

Police said the accident, which occurred at 2:35 a.m., caused them to shut down a section of the 1800 block of State Highway 183 for two hours.

"Anytime we have a severe accident like that, we close the highway for precautionary reasons and to take measurements," Tull said. "During that time of the day, there ... was not a lot of traf-

fic. Anytime you have two cars colliding head-on, you are going to have major damage."

This is the fourth fatality accident of the year in Irving, according to police reports.

Tull said Garcia, 19, was taken to Parkland Memorial Hospital, where he was treated for his injuries.

"He suffered Class A injuries," Tull said. "These are injuries that would cause a person to not be able to carry on their normal functions — something like a broken arm or leg."

On Monday, Garcia was released, according to officials at Parkland Memorial Hospital. Police are investigating the accident.
