Historical Sketch

The First Presbyterian Church of Irving was founded in December 1934 by Herbert S. Springall of the Dallas Presbytery's Home Missions organization and several Presbyterian families living in the Irving area. The 67 charter members held meetings first in their homes, and then in the auditorium at Irving's City Hall until their first building was completed in June of 1935. Springall served as the church's pastor until James E. Moore assumed that role at the first worship service in the new building.

The Irving church practiced the Presbyterian tradition of governance by "session," or council of church officials known as elders and deacons. Roy B. Wadsworth was an active member of the church's session from its founding until his death in 1962. Many of the records in the First Presbyterian Church of Irving Collection appear to have been compiled by Wadsworth.

The church added many new members over the decades and expanded its building in 1950 and again in 1967. Members of First Presbyterian also accommodated the growth of Irving's Presbyterian community by helping to establish new churches such as St. Stephen's Presbyterian Church which was founded in 1958.

This period of growth did not last, and due to a dramatic decline in membership, First Presbyterian was forced to sell its building to an independent church in 2009. The remaining congregation met for its final worship service and 75th anniversary celebration on November 8, 2009.

Scope and Content

The First Presbyterian Church of Irving Collection consists of correspondence, membership certificates, bulletins, minutes, financial records, printed material, plaques, and wall art. The bulk of the collection is housed in three manuscript boxes and one flat box. The remaining odd-size items include a hymnal, two plaques, and three framed pictures. The collection is separated into five series.

Series I is titled "Church History" and contains a single file folder. The file consists of the text of speeches on the history of the First Presbyterian Church of Irving from its beginnings in 1934 to the date of the latest speech in 1955. The file also contains source material used to write the speeches.

Series II is titled "Church Bulletins and Orders of Service" and contains 1.5 linear inches of orders of service with bulletins from the years 1944 and 1941-1955.

Series III is titled "Administrative Records" and contains 12.5 linear inches of records kept by the session of the church. This series is further divided by subject into five subseries.

Subseries 1 is titled "Membership" and contains four linear inches of certificates of church membership; correspondence regarding the transfer of membership from one church to another; lists of church members; and church directories.

Subseries 2 is titled "Session" and contains five linear inches of records of the session's activity from 1934-1962. The records consist of minutes; correspondence; resolutions; budgets; and reports.

Subseries 3 is titled "Music" and contains two folders of correspondence regarding the church's choir and organ.

Subseries 4 is titled "Buildings" and contains two linear inches of records related to the remodeling and expansion of the church building during 1950, 1966-1967, and 1983. The records include budgets; invoices; contracts; and sketches.

Subseries 5 is titled "Finances" and contains 1.5 linear inches of financial records.

Series IV is titled "Printed Material" and contains one linear inch of material produced by Presbyterian institutions other than the First Presbyterian Church of Irving including: bulletins; promotional literature; minutes; and a 1990 hymnal.

Series V is titled "Oversize Objects" and contains a table cloth, two plaques, and three framed wall hangings from the church building.

Provenance Statement

The First Presbyterian Church of Irving Collection was donated by the church to the Irving Archives in six accessions. Accession 0506-207 was donated on July 5, 2006; 0809-173 on August 10, 2009; 0809-186 on September 3, 2009; 0910-007 on October 29, 2009; 0910-012 on October 25, 2009; and accession 1415-054 on February 19, 2015.

and could not be filed alphabetically with the rest of the collection without causing some difficulty locating a particular name.

Contains certificates and letters from other churches either: dismissing members from their congregations to join the First Presbyterian Church of Irving, or requesting that FPCI dismiss members to join their congregations; and obituaries. The records are ordered alphabetically by surname. Also contains one 1928 letter dismissing a church member to a Presbyterian church in Dallas.

3 Dismissal Stubs, 1938-1958

Contains 3 books of certificates of dismissal given to church members who have left to join other churches. The certificates have been removed, leaving behind stubs with the former member's name, their new church, and the date the certificate was issued.

Attached to many of the stubs are certificates of reception from the former members' new church.

4 Infant Baptisms, 1945-1959

Contains information on infants baptized in the church including: names; parents' names; dates of birth; and dates of baptism.

5 Member List, c. 1945

Contains a list of church members written inside a notebook. The list consists of the members' names only.

6 Church Directory, 1952-1953

Contains a 1952 church membership directory with a packet of updates and corrections from 1953.

7 Church Directory, 1957

Contains a 1957 church membership directory.

8 Springall File, 1934-1937

Contains material collected by Herbert S. Springall during his time with the First Presbyterian Church of Irving including: correspondence; lists of church members; church bulletins; minutes of congregational meetings; and notes on the church's budget.

Contains a list of changes to a construction contract; a detailed list of locks on the church's doors; a list of materials and color selections for a remodeling job in 1967; and sketches for handrails that were installed on the stairway at the church's entrance in 1983.

Contains a file of material related to the Presbyterian Educational Fund campaign including: pamphlets; and correspondence. Also contains a fundraising letter from a campaign to build an addition to the First Presbyterian Church of Irving's classroom space.

13 Educational Fund (2 of 2), 1946-1949

Contains a second file of material related to the Presbyterian Educational Fund campaign including: fundraising letters and other correspondence; a list of pledges; and an informational booklet.

14 Fundraising, 1954-1955

Contains brochures and correspondence related to an intensive, month-long pledge drive by the First Presbyterian Church of Irving to raise money for its building fund and general budget.

15 Street Paving Improvements, 1959

Contains material related to improvements to the streets adjacent to the church property by the City of Irving including: assessment; tax bills; correspondence; and a right-of-way sale agreement.
