2022-2023 Availability  
Community Development Block Grant  
Public Services Funds*

The City of Irving is the recipient of Community Development Block Grant Funds (CDBG), used to address a range of Housing and Community Development activities. The City anticipates receiving an allocation of CDBG funds from the U.S. Department of Housing and Urban Development (HUD) for use effective October 1, 2022 through September 30, 2023. Eligible non-profit organizations are encouraged to apply for public services funding. Funds must be used to assist Irving residents and benefit low and moderate income persons/households. Applicant agencies must apply for program funding under one of the following specific categories: 1) Homelessness Services, 2) Physical and Mental Health Services, 3) Youth and Senior Services, or 4) Other Non-Housing Community Development. Eligible activities for public services funds may include but are not limited to counseling, child care, education, case management, and homeless prevention activities. Projects and activities must also meet eligibility requirements as defined by HUD and the City of Irving's Consolidated Plan.

All interested organizations **must attend a mandatory application meeting on March 11, 2022 at 10:00 a.m.**, in the Council Conference Room of Irving City Hall located at 825 W. Irving Blvd., Irving, TX 75060. Questions pertaining to the application will be answered during the application meeting. All questions outside the application meeting must be submitted in writing to the City of Irving's Planning and Community Development Department ([amiller@cityofirving.org](mailto:amiller@cityofirving.org)) by **March 18, 2022**. The City of Irving will only entertain questions from organizations that attended the application meeting, and any responses will be provided via email to all organizations that attended the application meeting by **March 24, 2022 at 5:00 p.m.** Please include your name, your organization's name and a phone number in your email, should the City need to contact you regarding clarification of your question.

Applications will be made available on **Tuesday, March 1, 2022**, online at the City of Irving's website found [here](#). A person or organization without internet access may obtain a copy of the funding application packet by contacting the Planning and Community Development Department at 972-721-4800. The application deadline is **5:00 p.m., Friday, April 1, 2022. No late or incomplete applications will be accepted.** Application submission requirements are outlined in the CDBG Notice of Funding Availability document found [here](#).

Application proposals will be reviewed by the Housing and Human Services Board. All applicants will present their proposals to the Housing and Human Services Board in **May 2022**, before being submitted to City Council for approval in **July or August, 2022**.
