

ORDINANCE NO. ORD-2023-10761

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE RUNOFF ELECTION HELD ON JUNE 10, 2023, FOR THE PURPOSE OF ELECTING THE COUNCIL MEMBERS FOR IRVING CITY COUNCIL, PLACE 3 AND PLACE 5, EACH FOR A TERM OF THREE (3) YEARS; PROVIDING FOR A SEVERABILITY CLAUSE

WHEREAS, the City of Irving, Texas, held a Runoff Election on June 10, 2023, for the purpose of electing Council Members to Place 3 and Place 5, each for a term of three (3) years; and

WHEREAS, public notice of the Runoff Election was duly given, and such election was duly and properly held and administered in accordance with the laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965; and

WHEREAS, a canvass of the Runoff Election returns was conducted on June 20, 2023; and

WHEREAS, it was found that the persons herein named received the following votes for said term of office on the Irving City Council of the City of Irving, Texas:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF IRVING, TEXAS:

SECTION 1. That the Runoff Election held on June 10, 2023 was duly and legally called, notice thereof given, and conducted in accordance with the Constitution and laws of the State of Texas, the Charter of the City of Irving, the Federal Voting Rights Act of 1965, and the ordinance calling said election; the election returns have been properly made to the officials of the City of Irving entitled to receive the same; and said election properly represents the desires of the voters of the City of Irving.

SECTION 2. That the following named candidates were duly elected at said Runoff Election to the respective named office of the City of Irving:

Abdul Khabeer – Council Member Place 3, District 3 – Single Member

Mark Cronenwett – Council Member Place 5, District 5 – Single Member

SECTION 3. It is hereby declared that the City of Irving approves and accepts the results of the Runoff Election for Council Members Place 3 and Place 5, as set forth in the Election Returns Sheet attached herein as "Exhibit A."



The City Council hereby declares that it would have passed this ordinance, and each section, subsection, clause and phrase, without the inclusion of any unconstitutional or invalid provisions.




SECTION 6. This ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.
